Ist eine Firma im Handelsregister erfasst, können Fahrzeuge - gegen Vorweisung einer rechtsgültig unterzeichneten Arbeitgeberbestätigung (Formular Mitarbeiterbescheinigung) - auch auf Mitarbeiter immatrikuliert werden, sofern die Fahrzeuge auch geschäftlich genutzt werden. Mindesthaltfrist beträgt 6 Monate.

DROIT DE REMISE POUR LES COLLABORATEURS LORS DE L'ACHAT D'UN VEHICULE DANS LE CADRE PROFESSIONNEL (GROUP II)

Lorsqu'une société est inscrite au registre du commerce, les véhicules peuvent également être immatriculés au nom de collaborateurs, dans la mesure où ces véhicules sont également utilisés à des fins professionnelles, à condition de présenter une attestation de l'employeur dûment signée (formulaire d'attestation collaborateur). La période de détention minimale générale est de 6 mois.

DIRITTO ALLO SCONTO COLLABORATORI PER AQUISTO VETTURE PER SCOPI PROFESSIONALI (GROUP II)

Se una ditta fa parte nel registro delle imprese, le vetture possono essere immatricolate anche a nome dei collaboratori, a condizione che le vetture siano utilizzate anche per scopi aziendali e dietro presentazione di una dichiarazione valida e firmata dal datore di lavoro (modulo attestazione di impiego). Il periodo di detenzione minimo è di 6 mesi.

DISCOUNT ENTITLEMENT FOR EMPLOYEES WHEN PURCHASING VEHICLES FOR BUSINESS USE (GROUP II)

If a company is registered in the commercial register, vehicles can also be registered to employees - on presentation of a legally signed employer's confirmation (form Employee confirmation, point b) - provided that the vehicles are also used for business purposes. Minimum holding period is 6 months.
